By this Contract the Participant confirms his intention to take part in the Exhibition, guarantees payment in full and undertakes to meet all the provisions of the Contract and the Exhibition Participant Handbook “RRFM 2013”.

For the purposes of the present Contract the following terms are accepted:

Exhibition: Exhibition, in the framework of the European Research Reactor Conference “RRFM – 2013”.

Timing of the Exhibition: April 22–24, 2013. Mounting of exhibition stands – April 21, 2013, demounting – April 24, 2013.

Organizer – LLC “Atomexpo”.

Participant – person on behalf of whom the Contract is signed.

PAYMENT PROCEDURE: The total cost of services for arrangement of participation in the Exhibition includes the following:

▪ Cost of exhibition area;

The payment is to be performed by the Participant as per issued invoices during ten banking days from the moment of the invoice reception by funds transfer to the Organizer’s current account. The invoices will be issued upon reception by the Organizer of the signed Contract.

The Participant will pay via bank transfer in the following order:

Advance payment amount of which is equivalent to 100 % of the service cost as per the CONTRACT shall be performed within **10 (ten) banking days from the date of invoice issuing.**

Supplementary services ordered by the Participant during the Exhibition performance period shall be paid based on the invoices issued by the Organizer not later than in 5 (five) banking days after the Exhibition closure.

Violation by the Participant of the payment terms entitles the Organizer to refuse in its sole discretion from the present Contract performance and not to grant admittance to the Exhibition for the Participant.

Upon the closure of the Exhibition the Participant shall sign an Act about the rendered services during five days from its receiving.

All bank fees and commissions are to be charged off the payer.

RIGHTS AND OBLIGATIONS OF PARTIES: The rights and obligations of the Participant under the CONTRACT cannot be transferred to any other person. The Participant may not arrange exhibit items of the third parties on his exhibition area without coordination with the Organizer. The Participant shall use the exhibition spaces as intended only and in compliance with the stand Layout. Distribution of promotional materials or other types of advertising activities shall be performed by the Participant within his stand only. The Participant shall organize and arrange his exposition in such a way that it does not make difficulties for the flow of visitors in the passages and does not create a threat to or infringement of rights of other participants and visitors. The Exhibition participant is obliged to fulfill the safety regulations, preventive fire-fighting regulations, industrial health regulations effective at the territory of Courtyard Marriott Pushkin Hotel. During the Exhibition performance the participant may not legally perform any actions which are forbidden by or contravenes the effective legislation of the Russian Federation. The Participant is entitled to demand from the Organizer in the written form to remove any disadvantages in provided services within the period not exceeding one working day from the moment of receiving the respective written request of the Participant. In case no claims regarding removal of disadvantages are received from the Participant the services will be considered to be properly provided.

LIABILITIES OF PARTIES: Participant is obliged to compensate to Organizer any harm to Organizer’s property as well as Organizer’s expenses for compensation for harm caused by the Participant to property of the third parties. Violation by the Participant of the service payment terms entitles the Organizer to refuse in its sole discretion from the CONTRACT performance and not to grant admittance to the Exhibition for the Participant. Organizer is not liable for loss or damage of exhibit items or other inventory items belonging to the Participant, during the Exhibition mounting, demounting and performance.

REFUSAL TO PARTICIPATE IN EXHIBITION: Refusal of Participant to participate in the Exhibition or to perform the CONTRACT terms and conditions implicates the payment by the Participant to the Organizer of a penalty in amount of 100 % (one hundred per cent) of the participation cost specified in page 1 of the CONTRACT.

REDUCTION OR CHANGE OF DECLARED AREA: If the Exhibition Participant reduces the exhibition stand area after the Organizer has received the CONTRACT signed by the Participant, but not later than 30 days before the Exhibition beginning, the Participant shall pay a penalty in amount of 50 % of the differential cost of the exhibition area caused by reduction of the exhibition stand area. If the Participant reduces the exhibition stand area later than 30 days before Exhibition beginning, the transferred money will not be returned. In extraordinary circumstances the Organizer reserves the right to change the location and size of provided exhibition area after the CONTRACT signing.

CANCELLATION OR CHANGE OF THE EXHIBITION TIMING: In case of change of the Exhibition timing or cancellation and provided that the Participant has been notified of that not less than one month prior to its opening, the Organizer bears no responsibility before the Participant for expenses incurred by the latter one due to the Exhibition timing change or cancellation. Herewith the Organizer shall return to the Participant the monetary resources received from him upon the Participant’s request.

FORCE-MAJEURE: The Parties are not liable for non-performance or improper performance of their obligations under the CONTRACT which occurred as a result of circumstances of insuperable force, i. e. extreme and unavoidable circumstances, including fire, act of terrorism, natural disasters, war, military operations of any type, decisions of governmental authorities. A Party which did not perform or improperly performed its obligations due to force-majeure circumstances shall immediately inform the other Party of such circumstances occurrence and termination. Adequate evidence of occurrence of the above circumstances and their duration will be the documents (information sheets) issued by respective competent authorities.

INSURANCE: Insurance of all exhibit items, freight, staff and other risks shall be carried out by Participant at his own expense.

ARBITRATION: All disputes and disagreements between the Participant and Organizer shall be solved mutually by negotiations, and in case of failure to achieve the consent they shall be settled in an arbitration court for resolution of economic disputes at the Private foundation “Center for arbitration and legal examination” in compliance with its rules. The arbitral award is final. Applicable legislation is the material law of the Russian Federation.

MISCELLANEOUS: All requests for supplementary services related with the participation in the Exhibition are the integral part of the CONTRACT. In all other things not provided under the CONTRACT the Parties shall follow the Exhibition Participant Handbook “RRFM 2013” and effective legislation of the Russian Federation.

DURATION OF THE CONTRACT: THE CONTRACT is considered to be concluded from the moment when Organizer receives the CONTRACT signed by the Participant and is valid till May 30, 2013.
